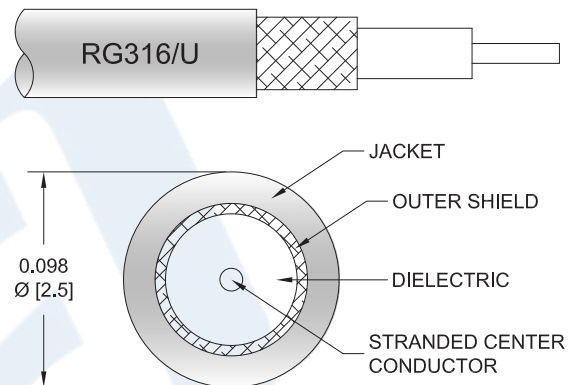

This Pasternack MCX to TNC cable assembly has a plug to female gender configuration with 50 ohm flexible RG316 coax. The PE3W05645 MCX plug to TNC female cable assembly operates to 3 GHz. Our RF cable assembly with TNC bulkhead interface allows designers to create external connections on their product enclosures, and can be used in a variety of other rack mount and panel mount applications.

Custom versions of most RF cable assemblies can be built and shipped same day. Custom cable assembly lengths can be obtained by specifying the desired length on the web site at time of order or by contacting a sales representative. Other available RF cable assembly value added services include connector orientation or clocking, heat shrink booting and custom labeling. 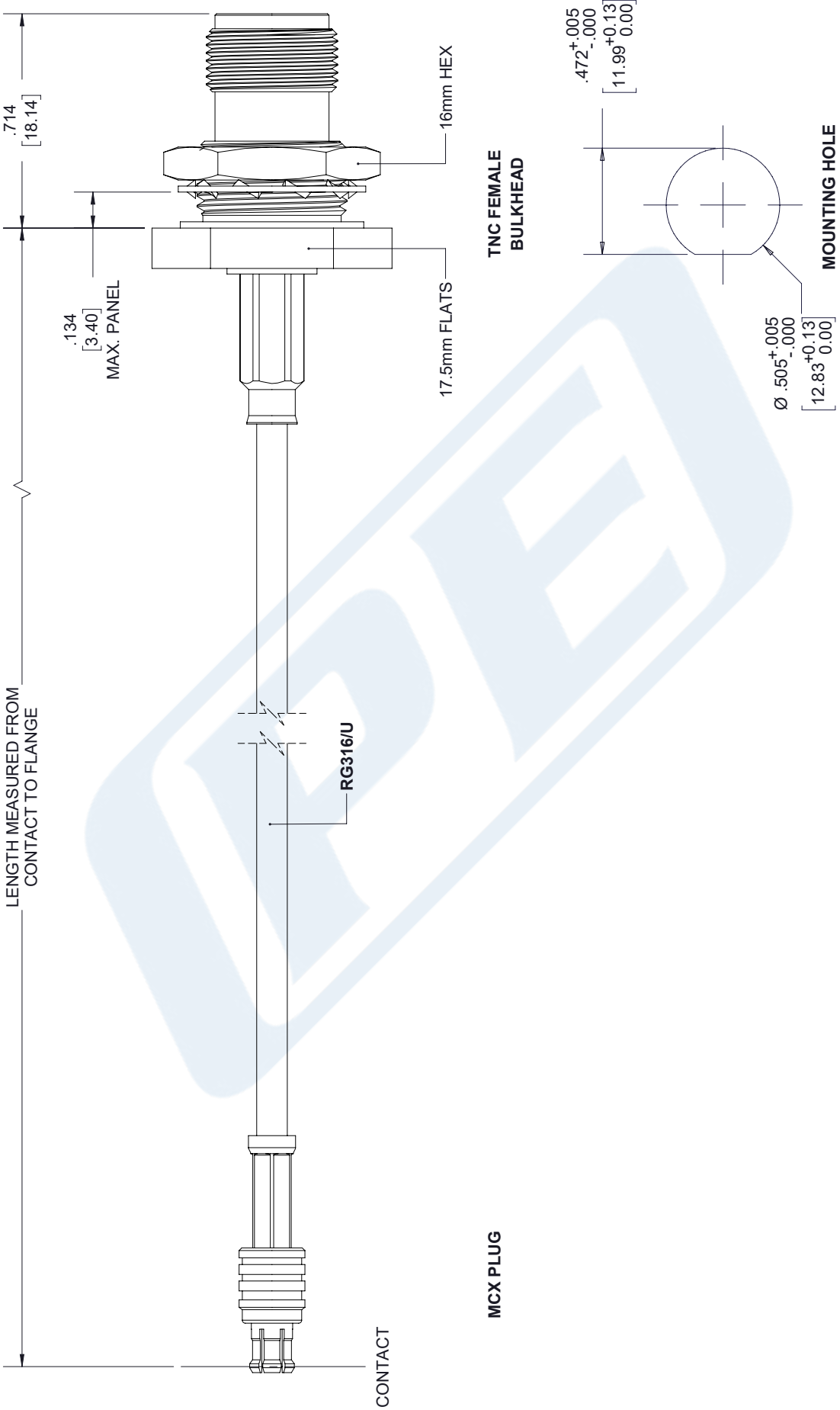
